ADDITIONAL PROVISIONS**



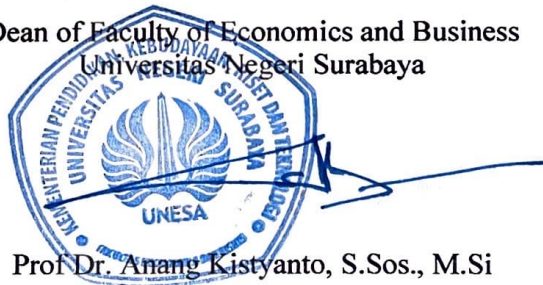
