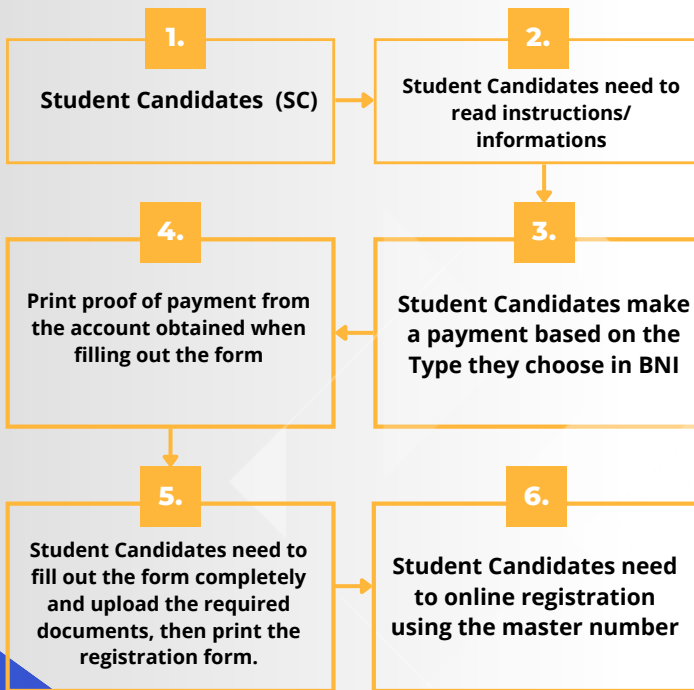

HOW TO REGISTER

1. Paying the registration fee for new postgraduate students at Universitas Negeri Surabaya at Bank BNI (Billing Code 12 for Masters and 14 for fresh graduates of all branches in Indonesia to obtain an Identification Number for the online registration process on the website:

2. Complete the registration form and upload portfolio documents in the form of:
 - Files of diplomas and undergraduate transcripts that have been legalized according to the requirements along with proof of BAN-PT accreditation.

 - Scientific work that has been published and/or evidence of scientific activities that have been followed.
 - Letters of recommendation from two people who know the academic ability and personality of prospective new students. Format can be downloaded from the page: <https://sipenmaru.unesa.ac.id/>
 - Proof of English proficiency (TOEFL/IELTS/TOEIC/TEP)
 - The research idea designed for the thesis includes the research problem, objectives and research methods.
