

## Minutes Meeting

On Monday, May 27, 2025, sanctioning was carried out at the Sociology Study Program, Faculty of Social and Political Sciences, Unesa. This activity invited experts to evaluate the study program curriculum. On this occasion, the expert invited to this activity was Prof. Dr. Tyas Retno Wulan, S.Sos, M.Si. This activity was carried out in a hybrid manner because there were participants who attended offline and online. The activity began with the delivery of the curriculum with a presentation of the Study Program curriculum by the Quality Assurance Unit (UPM) of the Sociology Study Program, Mr. Pambudi Handoyo S.Sos, M.Si. Input from experts is one of the mandatory principles: curriculum evaluation every 4-5 years. However, when we determine the evaluation of the curriculum, PEO, CPL. It is not just 5 years. But the most important thing is the analysis of stakeholder needs. There are special specifications that differentiate between the 4 study programs in Surabaya. Identify the advantages of UNESA Sociology with the 4 Sociology Study Programs in the Surabaya area. Expert input is crucial for improving the Unesa Sociology Study Program curriculum, ensuring it produces graduates who are competitive in the workforce. Mr. Agus: "I request input on the Unesa Study Program curriculum, particularly as we enter the transition/change process of MBKM. MBKM is aimed at one semester. The study program will undergo recredentialing through Lamspak and Acquin international accreditation."

Input and suggestions from Prof. Dr. Tyas S.Sos, M.Si:

1. LP3M Template (LPPMP), which is in accordance with APT 2024. For compliance
2. There are principles that have not been implemented
3. Advantages of Unesa's Sociology Curriculum: detailed MBKM, KKNT descriptions that are not yet available in other sociology study programs.
4. Cons: Be careful, as many international accreditations were advanced in 2023. However, these are no longer recognized by the Directorate General of Higher Education, including Acquin.
5. One mandatory principle is a curriculum evaluation every four to five years. However, when we determine curriculum evaluations, PEO, and CPL, it's not just every five years. The most important thing is an analysis of stakeholder needs. However, this hasn't been done yet. There are specific specifications that differ between the four study programs in Surabaya. What are the advantages of UNESA's Sociology compared to the four other sociology programs in the Surabaya area?
6. A profile based on internal and external strengths and a tracer study (where the alumni went to) should have been created, whether they were teachers, social entrepreneurs, or social welfare workers. A tracer study should be described (mandatory). This serves as an urgent and legal basis for appropriate changes to the study program profile.
7. The revision and public testing process that needs to be carried out:

- Who is invited?
- Which users are invited?
- Which alumni are invited?

8. Care must be taken when revising the curriculum to avoid prejudice. Why was the Constitutional Court removed or changed? Because it was no longer relevant. Recommendations from Digital Sociology.
9. The curriculum foundation must exist.
10. The study program's vision and mission are already in place, but there's no linkage with the university's, faculty's, and study program's visions and missions. How can stakeholders be involved in developing the vision and mission?
11. Ideally CPL is 12 points.
12. There is no report on the total number of courses and credits per semester. There are no RPS and assessments. Monitoring and Evaluation Reports.
13. Each final assignment depends on the Study Program CPL.
14. The development is carried out according to the needs and developments in science and technology. It is hoped that each stage will require the involvement of all lecturers. This will avoid accusations of eliminating certain courses. This will ensure that students understand from the outset why courses are being removed or shifted.
15. Course organization is the final stage of the curriculum revision. Before that, input from associations, alumni, and student users is essential. Once everything is clear, the mapping process is all that's left to do.
16. Certain universities within the social welfare department at Unej require certification to graduate. Social welfare specialists must have specific certifications. Are specific courses required to support social welfare studies? What are they optional or?


### Discussion Session

## Minutes Meeting

On June 24, 2025, the Sociology Study Program at Unesa invited experts from Edith Cowan University, Australia, to provide input on the Sociology Study Program curriculum. This initiative was carried out to ensure the Sociology Study Program consistently provides the highest quality education to its students. Input from international experts is crucial for comparing teaching and learning activities at Unesa with those in Australia, ensuring that our graduates are not only competitive locally but also globally.

The event was moderated by Mrs. Rizky Trisna Putri, SP, M.Si, and opened by the Dean, Dr. Wiwik Sri Utami, MP. In her remarks, the Dean welcomed the holding of this event to improve the quality of learning in the Sociology Study Program of Fisipol and achieve the goal of becoming a World Class University in 2025. Prof. Ferry Jie also welcomed and prayed that the Unesa Sociology Study Program could continue to develop and have a teaching system that is in accordance with global needs.

Currently, *curriculum mapping* is needed to identify gaps and alignment between the curriculum and current developments in the workplace. Furthermore, *a redesign process* is needed to align the curriculum with global trends and needs. One example of this, implemented at Edith Cowan University, is the student *internship program*.

Prof. Ferry also explained the benchmarking process at several universities worldwide, including several in Indonesia. This process is crucial for assessing curriculum developments at both international and Indonesian universities. The Sociology Study Program also needs to continuously monitor these developments to identify the unique characteristics of the UNESA Sociology Study Program. The Sociology Study Program remains committed to maintaining curriculum quality to produce top-notch graduates ready to compete in the local and global workforce.

## **Minutes Meeting**

June 24, 2025, the Public Test of the Sociology Study Program Curriculum was held, inviting alumni and professionals. This event was held in a hybrid manner, with some invited guests coming to FISIPOL UNESA and some connecting online. The event was opened by the Study Program Coordinator, Dr. Agus Machfud Fauzi, M.Si. He expressed his gratitude to the invitees who had taken the time to attend the Public Test of the Sociology Study Program Curriculum. He hoped that the invitees would provide input regarding the Sociology Study Program curriculum so that the Sociology Study Program curriculum can be continuously improved to adapt to the needs of the times.

On this occasion, Mr. Pambudi Handoyo, S.Sos., MA, as the UPM Sociology Study Program, explained the curriculum description of the Sociology Study Program. This event was moderated by Ms. Wardatul Adawiah, S.Pd, M.Si. After the curriculum presentation, the invitees were enthusiastic to provide input. One of the inputs was from the Chairperson of the Surabaya City Sociology MGMP who provided information that there are many vacancies for Sociology teachers so that they can be maximized in the curriculum so that it can become a career choice for graduates.

Alumni also provided input. Mr. Andrew Nababan, a 2005 Sociology Study Program alumnus who is currently working in the creative industry, suggested that the study program provide more opportunities for students to practice in the field. He also said that Sociology Study Program graduates should be proud because they can enter any sector. Meanwhile, Novitasari, a 2019 Sociology Study Program alumnus, suggested that the main learning of social research methods also provide students with skills in using the latest applications such as N - VIVO so that they have provisions in conducting field research for their final assignments. Likewise, online invitations also enthusiastically provided input to the Sociology Study Program. The Sociology Study Program appreciates and is grateful for all the input provided and strives to always provide the best quality for students.

### **1. Input from Mrs. Umi\_ Sociology Teacher:**

One of them is producing teachers, lecturers tutors: The problem that arises is the courses can be used/utilized in the community. Most of them are graduates of pure sciences. Sociology number of 153 private and public high schools. 22 public high schools with civil servant status 8 people. P3K the remaining 20 people. The delivery of classical sociology material in high schools while at university they get Modern Sociology. New teachers do not have the strength of pedagogical knowledge. Suggestion: elective courses (interest) can be based on grouping GP1, GP2, etc.

### **2. Input from Mr. Andre\_Music and Events (Creative Industry):**

Many are talent agencies, rental companies, and MCs. Stand-up comedy is often used as dark jokes. The rise of social media has fueled interest in sociology. They need up-to-date instructors. Their studies focus on the creative industry, as this phenomenon must be embraced with relevant theory. Practically, they reinforce the use of sociology for practical work. This is linked to industrialization.

Communication sociology did not exist in the 2015 curriculum. The only social person in the workplace. A science that is not studied but works in a non-linear environment. The problem of internships in private companies. Village sociology courses, research methods as compulsory subjects, require in-depth social analysis. Only one entrepreneurship seminar was held. Entrepreneurship seminars and practical training programs should be included to expand student relationships.

Career advice: Highly relevant to environmental sociology. Implementative science that meets market needs requires a common thread to draw comprehensive conclusions from the course. Environmental sociology can be directly contextualized into environmental impact analysis (EIA). Sociology graduates must understand methodology, for example, the power of quantification methods.

## **5. Mas Bagus\_ Lecturer at UTM, Unair and UB**

Three universities are experiencing a surge in students, leading to a dehumanization of the teaching profession. One aspect that needs to be strengthened is the role of field lecturer assistants. Research methods and data correlation in the field are crucial. An adaptive curriculum is needed. **Add: Field Lecturer Assistants.**

## **6. Mr. Edi \_ Lombok Regional Government**

What professions should sociology graduates pursue? It's necessary to map out the positions sociology graduates can take. Based on CPNS positions: social counselor, disaster relief worker, family planning worker, proposer of minutes for the central Indonesian House of Representatives, policy analyst at the central level.
