Considering: a. CPL measurement is a crucial element in the OBE Curriculum ecosystem, serving as a navigation tool indicating whether learning is aligned with expected competencies;

b. CPL measurement enables academic programs to evaluate how well curriculum objectives have been achieved. Thus, this measurement is not merely a formality but a quality control element for educational outcomes;

c. CPL measurement results provide concrete feedback on curriculum design and implementation. If graduates do not achieve certain CPL, then the curriculum, teaching methods, or evaluation strategies need to be reviewed;

d. Accreditation bodies such as BAN-PT or LAM emphasize the importance of measurable CPL as evidence of an educational institution's accountability. This forms the basis for evaluating the quality of study programs and institutions;

e. With appropriate CPL measurement, institutions can verify that their graduates possess competencies relevant to industry needs, society, and contemporary developments, as well as aligning with the Graduate Profile description;

f. CPL measurement also helps create transparency in learning outcomes for stakeholders (parents, industry, and society) and demonstrates academic accountability;

g. Based on the considerations outlined in points a through f above, it is necessary to establish this decision.

Grading	Notes	Explanation
80	Excellent	Indicates that the student has mastered the graduate competencies comprehensively and deeply. Not only does the student meet all learning outcome indicators, but also demonstrates excellence in application, problem-solving, and innovation.
70-79	Very Good	Students have mastered most of the learning outcome indicators very well . They are able to demonstrate stable, independent, and high-quality performance, although they have not yet reached the highest level of excellence.
60-69	Good	The basic competencies targeted in the CPL have been sufficiently met , with good understanding and skills. There is still room for improvement in some aspects of analysis or application, but students are considered eligible to pass.
55	Average	Students only meet the minimum standards for learning outcomes. Their understanding is functional but limited to basic aspects and needs further reinforcement.
< = 54	Poor	Students have not achieved the minimum competencies expected in the CPL. This indicates a lack of mastery of the material, skills, or attitudes being measured. This category typically requires remediation or repetition of the learning process.
